*The applicant or a family member related by blood or marriage shall personally sign the application for an absentee ballot; or, in case of the applicant's inability to sign, another person shall witness the elector's mark.

First Time Voters Who Registered By Mail

If you are registered to vote for the first time in the state of Colorado and have registered by mail, **a copy of one of the following forms of identification information is required to be submitted with the Absentee Ballot:**

- A valid Colorado Driver's License; or
- A valid Colorado Department of Revenue identification card; or
- A Valid U.S. Passport; or
- A valid pilot's license with photograph issued by the Federal Aviation Administration; or
- A valid employee identification with a photograph issued by the US Government, Colorado State Government, or any county, municipality, board, authority or other political subdivision of the state; or
- A valid US Military identification card with photograph; or
- A copy of a current utility bill, bank statement, government check, paycheck, or other governmental document that shows the name and address of the elector; or
- At least the last four digits of the person's social security number.

The approved forms of identification must show your address as being in the State of Colorado.

Do not include original documents with this application.

COLORADO MUNICIPAL ELECTION LAW REQUIRES THAT IN ORDER FOR YOUR BALLOT TO BE COUNTED, IT MUST BE RECEIVED AT 5395 LAKESHORE, BOW MAR, COLORADO **BEFORE** 7:00 PM ON THE DAY OF THE ELECTION. BALLOTS MAILED TO 4302 W. BELLEWOOD DR., LITTLETON, CO, WILL BE TRANSPORTED TO 5395 LAKESHORE DRIVE FOLLOWING DELIVERY OF U.S. MAIL ON THE DAY OF ELECTION.
